

# 2008 History Cruze Food Vendors

North Saint Paul's History Cruze celebration will be held from June 6 – August 29, 2008 from 6:00 pm to 10:00 pm. (Dates and hours subject to change).

We are now accepting applications for food vendors for The History Cruze, held in historic Downtown No. St. Paul. The History Cruze has evolved into a festival of pre-1975 cars, trucks, music, arts/crafts and foods. Our show once again will highlight North Saint Paul's historic 7<sup>th</sup> Avenue & Margaret Street. The event will include activities and entertainment for everyone from children to seniors.

We hope that you will join us for another successful year! We would like to have your completed application and check by May 15, 2008 in order to reserve your spot. Please call, if you should have any questions.

## FOOD VENDOR GUIDELINES AND REQUIREMENTS

### Eligibility

All History Cruze food vendors must have a valid Minnesota State Tax Identification Number. If you do not have one, one may be applied for by calling Minnesota State Sales Tax and Excise Division at (800) 657-3777 or (651) 296-6181. All food vendors must collect and pay sales tax on each taxable sale made at The History Cruze. The event staff reserves the right to jury entries and to ask a food vendor to leave the event should their behavior be deemed inappropriate by the event staff. History Cruze staff reserves the right to refuse and stop sales or give away of products before or during the event that any of our staff deems inappropriate to the show. i.e. (Silly String, Snaps, Stink Bombs, etc.)

### Food Vendor Space

Booth space will be assigned by the Event's committee in the designated areas of Seventh Avenue in Downtown North St. Paul where the festival's sponsors have deemed appropriate. No moves without prior authorization by the History Cruze board members. Each vendor is responsible for all costs to clean up any grease or oil stains/spills at the end of each Friday night. Otherwise you will be contacted by the city or the History Cruzers staff.

### Food Vendor Hours

All food vendors must be set up and ready for business by opening each Friday they appear and shall be manned and open no earlier than 3:00 pm and no later than 5:30 pm on the day of the show. Food vendors may be open until 10:00 pm and may stay open beyond this time. Hours subject to change without notice. No vendors will leave anything anywhere in the downtown area overnight at any show. Each vendor is responsible to haul away internal trash at the end of each show.

### Food License

All food vendors are required to have a Ramsey County, State of Minnesota or Dept. of Agriculture food license. This WILL be enforced. To contact the Health Dept, please call 651(266-1199).

### Food Vendor Fees

All spaces up to 10' x 10' will be rented for \$600.00 for each vendor. There is no electricity anywhere in the downtown; all food vendors must supply their own electricity. Please make checks payable to "The North St. Paul History Cruze".

### Insurance and Indemnity

All History Cruze vendors, participants and exhibitors agree to hold The History Cruze, The History Cruze Events Committee, the City of North St. Paul, and all History Cruze sponsors harmless from all liabilities and claims. Exhibitors will be fully responsible for insuring their own actions and property in connection with The History Cruze. Exhibitors are responsible for security and storage of their own items. The exhibitor is responsible for handling and safeguarding its own cash during the car shows.

**NOTE:** History Cruze board members reserve the right to terminate any vendor, at any time, without offering refunds.
